As a Senior Business Process Analyst (BPA) for Export Control division, you will be the key liaison between Compliance & Export Control departments and the IT organization. Your primary mission is to assess, refine, and implement business processes and related information systems (e.g., SAP/GTS) to enhance their effectiveness, ensuring they align with legal priorities and the company's strategic direction.

#### Key Responsibilities:

- ✓ Act as the first IT contact for business stakeholders and process owners in the Compliance & Export Control departments.
- ✓ Assess, change, and refine business processes and related information systems (e.g., SAP, external customs declaration systems) to ensure effectiveness and alignment with strategic priorities.
- ✓ Play a key role in IT development and implementation projects, managing transitions from development to support phases.

#### Support Functions:

- ✓ Serve as the bridge between the business organization, IT organization, and outsourcing partners, including customs authorities and IT service providers.
- ✓ Document "as-is" and "to-be" processes and assist in developing business case transitions.

- ✓ Drive change and handle resistance, providing leadership and direction in high-pressure environments.
